Buz M. Walker, 1925-1930



Bio/History Note

Buz M. Walker was born in Oktibbeha County, Mississippi on August 20, 1863, and was one of the first graduates of Mississippi A. & M. College, graduating in 1883 with a degree in Mathematics. Walker joined the college faculty later that year and spent the next 40 years with A. & M. During summer breaks, he studied at the University of Virginia, the University of Berlin, and the University of Chicago, where he received his PhD. Walker succeeded Hull in 1925 and served as president until 1930, when he resigned to accept the chairmanship of the Mississippi Association of International Patents. After leaving A. & M., Dr. Walker and his wife, Blanche, wrote and recorded many ballads which were played on radio stations across the nation.

Scope and Content Note

This collection contains materials from the tenure of Mississippi A. & M. President Buz M. Walker, who served from 1925-1930. It consists primarily of correspondence arranged alphabetically by correspondent name within each year. The lettered miscellaneous files contain general correspondence from miscellaneous parents and students, as well as people conducting business with the university. Topics include: ROTC, veterans' issues, campus traffic, job applications, Board of Trustees minutes, and miscellaneous university business. Materials also include reports, pamphlets, and brochures.
